**Opinion**

We have audited the accompanying Standalone Annual Financial Results of **Jattashankar Industries Limited** (lithe Company") for year ended 31<sup>st</sup> March 2021, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended (lithe listing regulations").
